

TENDER NOTICE

As per the law N° 03/2013 of 8/2/2013 determining its mission, organization and functioning, the MHC is mandated with "capacity building" of the media sector.

The Media High Council (hereinafter called "Client") has received funds from Ordinary budget towards the cost of the different services, the Client intends to apply a portion of the funds to eligible payments under the contract for which this invitation is issued.

The Media High Council (MHC) hereby invites qualified bidders to submit their offers for the following tenders as indicated in detail in the Tender Document for each tender to the Media High Council:
